# Activity Plan for the Azerbaijan National Platform (AZNP)

#### Background:

The Azerbaijan National Platform of the Eastern Partnership Civil Society Forum (AZNP) was established in November 2009 and currently comprises 71 diverse organizations. AZNP's mission revolves around actively engaging Azerbaijani civil society in the EU's Eastern Partnership policy, fostering collaboration with the EU, enhancing dialogue between the EU and Azerbaijan's government, supporting civil society reinforcement, and safeguarding human rights and freedoms through increased public involvement.

AZNP has developed several key strategies to drive its mission forward, including a Strategic Plan, a Communication Plan, a Visibility Plan, and an Advocacy Strategy. These strategies outline AZNP's goals, approaches, and objectives to create a positive impact in Azerbaijan.

# Objectives:

- 1. Enhance Organizational Effectiveness: Strengthen AZNP's capacity to fulfill its mission and objectives.
- 2. Raise Awareness and Engagement: Increase awareness of AZNP's mission, engage stakeholders effectively, and foster support for its initiatives.
- 3. Advocate for Policy Change: Influence policy reforms aligned with AZNP's mission and create an enabling environment for civil society.

#### **Outcomes:**

- 1. Improved Organizational Capacity: AZNP becomes a more efficient and influential platform for civil society organizations in Azerbaijan.

#### Activities in Detail:

Objective 1: Enhance Organizational Effectiveness

Outcome 1: Improved Organizational Capacity

- Activity 1.1: Strengthen Working Groups and Board of Directors: Organize capacitybuilding workshops and training sessions for AZNP members to enhance their skills and knowledge in areas relevant to their roles.
- Activity 1.2: Develop Ethical Behavior Rules: Facilitate the development and implementation of ethical behavior rules for AZNP members to ensure transparency and accountability.
- Activity 1.3: Website Development: Maintain the AZNP website to serve as an operational hub for information sharing and engagement.
- Activity 1.4: Regular Meetings: Establish a schedule for regular working group meetings and facilitate annual meetings to foster communication and collaboration among AZNP members.

Objective 2: Raise Awareness and Engagement

Outcome 2: Enhanced Visibility

- Activity 2.1: Public Awareness Campaigns: Execute public awareness campaigns
  using a mix of media channels, including social media, traditional media, and online
  platforms, to reach the general public in Azerbaijan.
- Activity 2.2: Stakeholder Engagement: Organize consultations and meetings with government officials, civil society organizations, and international partners to build support for AZNP's initiatives.
- Activity 2.3: Educational Initiatives: Conduct seminars, webinars, and workshops to inform the public and key stakeholders about AZNP's mission and objectives.





• Activity 2.4: International Collaboration: Collaborate with international organizations and diplomatic missions to amplify AZNP's visibility and influence on the international stage.

- Activity 3.3: Advocacy Campaigns: Execute targeted advocacy campaigns, leveraging grassroots mobilization, to influence policy changes at the national and international levels.
- Activity 3.4: Lobbying and Advocacy: Engage in direct advocacy with government bodies, parliamentarians, and relevant ministries to promote policy reforms.
- Activity 3.5: Media Engagement: Utilize media engagement, op-eds, and press releases to raise awareness about policy issues and advocate for change.
